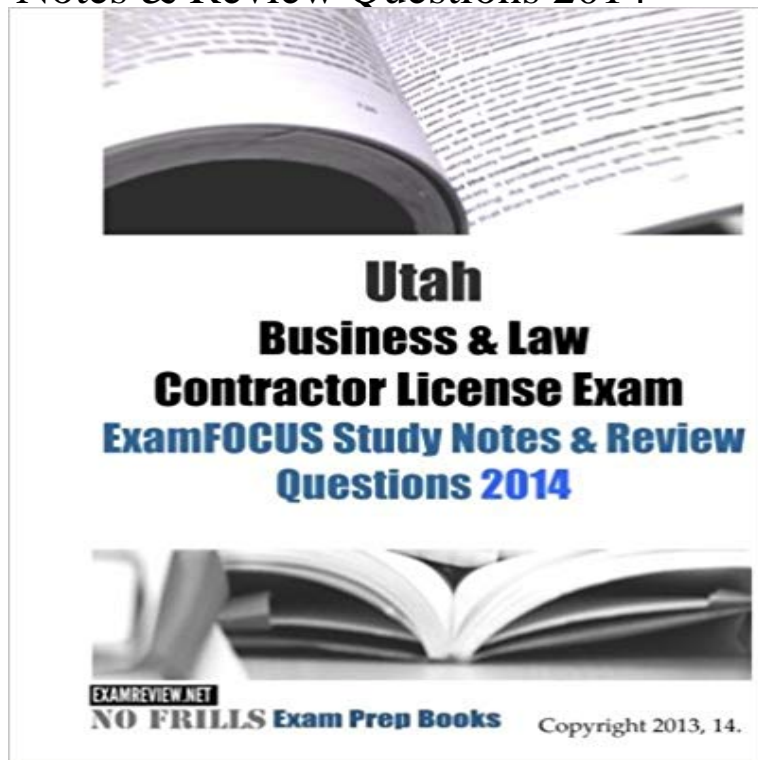


# Utah Business & Law Contractor License Exam ExamFOCUS Study Notes & Review Questions 2014
