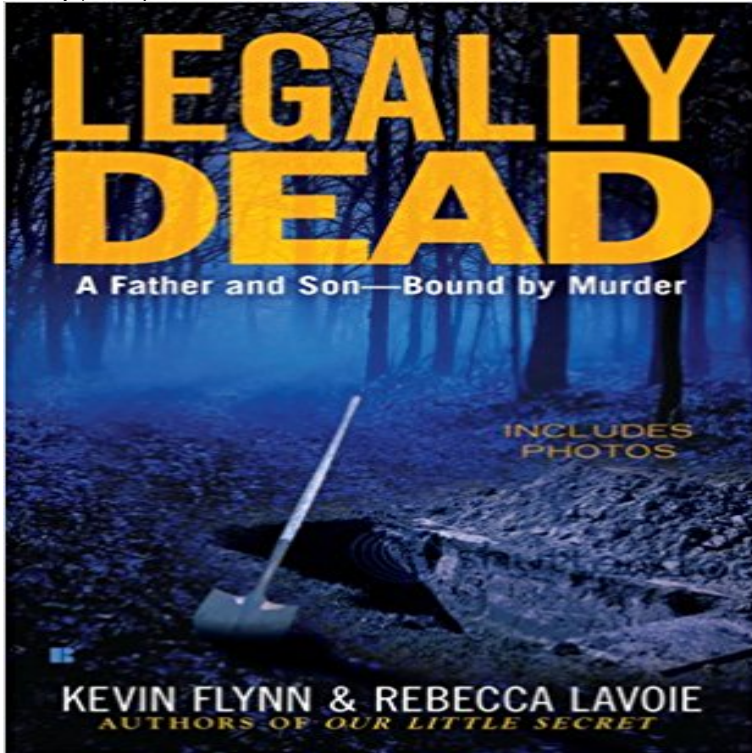


## Legally Dead : A Father and Son Bound by Murder
